For years, these people simply went without healthcare since they do not have insurance. And with the recent TennCare cuts, more people are falling into this niche. Our clinic was established in 1991 after seeing the great need for help with the underserved population. At Interfaith, we provide medical and dental care, counseling, social services, and medications on a sliding fee scale. Since patients pay on a sliding fee scale, the majority of funding for the clinic comes from donations and grants. With the TennCare cuts we have an increased demand for care, and an increased need for donations. We are a non-profit organization, so your donations are tax deductible. We send receipts requested for all donations. And we don't need just funding. If you have any old equipment or supplies

Also to help off-set the high costs of patient care, we have many on-site and offsite volunteer providers. Dentists, oral surgeons, endodontists, doctors, nurses, specialists of all kinds in their own offices....all giving of their time to help those in need. Although over 40,000 people in Knox County alone are without insurance, our patients come from anywhere....even as far away as Georgia and Virginia.

A lot of you have heard of Interfaith, but people are telling me many of you don't know what Interfaith is about. The Interfaith Health Clinic provides patient care where the health department financial guidelines end. Where their guidelines end, ours begin. We take care of patients that are working or have an income, but it is a very low income. And they do not have medical or dental insurance, so they cannot afford healthcare at today's out-of-pocket costs. These people are trying to make ends meet and do not want a free handout. We give them a hand up.
