Dr. Hughart was born in Fairfax, VA. However, he grew up in southern West Virginia. He graduated from Concord College in Athens, WV, in 1989 with a Bachelor's degree in Accounting. Upon graduation from Concord he started his Accounting career with the Commonwealth of Virginia as an auditor. He passed the CPA exam in 1990. In 1992 he left his position as an auditor to enroll in the Master's of Accounting program. After graduation from Virginia Tech he relocated with his wife Torie to Winston-Salem, NC to work for Wachovia Bank.
