Appliance therapy is more than just making a protective night guard for people who grind their teeth. With a simple piece of plastic there is tremendous opportunity for making connections, giving comfort, building relationships, diagnosing, and learning about our patients. Appliance therapy can be one of the most fun and rewarding aspects of dental practice.

This presentation will discuss the application of appliance therapy, different kinds of appliances and their advantages and limitations, and how to transfer learning (yours and your patients') from the appliance to predictable dentistry. We will also discuss how this can be practically be applied successfully and profitably.
