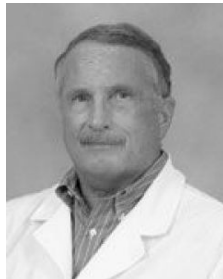

**When one thinks “Oral Pathology,” only major entities come to mind including cancer, huge cysts and tumors, etc. In truth, the majority of oral pathology seen in the office consists mostly of small, non-malignant lesions.**

**Dr. McCoy will present a wide spectrum of the lesions seen quite commonly in the dental office as well as a few of the more major ones. In addition, “there won’t be a quiz afterwards.”**

**Dr McCoy obtained his DDS from West Virginia University. He then completed his residency and fellowship training at the Medical University of South Carolina in Charleston, the Walter Reed Army Medical Center in Washington, Emory University in Atlanta and the University of Tennessee Graduate School Of Medicine here in Knoxville. He is a diplomat of both the American Board of Oral and Maxillofacial Surgery and the American Board of Oral and Maxillofacial Pathology. Presently Dr McCoy is a Professor of Pathology, Radiology and Oral and Maxillofacial Surgery ~ as well as the director of the Hyperbaric Oxygen Unit at the University of Tennessee Graduate School of Medicine here in Knoxville.**
